Secretary Berlinger distributed the minutes from the Annual Business Meeting from November 8, 2020. The minutes were review and approved unanimously. No other business by Secretary Berlinger.

Treasurer Downey presented the current financial status and balance report. Balance as of November 6, 2020, was \$8,026. The current balance as of this date is \$39,224. Deposits or checks pending amount is (-) \$1,126.17 giving an adjusted balance of \$38,098. See attached treasurer's report for detailed transactions summary from November 6, 2020, to date. With a current balance of \$38,098, the board voted on and unanimously approved a \$30,000 donation to the American Cancer Society. It was noted that this would still leave us a balance of the required \$5,000 prudent reserve.

President Finney congratulated Rose McCaffrey for her first extremely successful chairing of the auctions. Bob Graves interjected the same congratulations to Gena Thomas for her very well organized first registration committee.
- Once again work on sponsorship for the 2022 (49th) event needs to start as early as possible. We did regain several sponsors this year that dropped out last year, but we need more major sponsors.
- Insurance covering the SPSC and the Smith Regatta went up from \$1,751 to \$1,878 this year. It was noted that the insurance covers on the water activities, sailors and on-beach activities. The Smith

Regatta portion of the insurance cost will remain at \$800 for now. This can be re-visited at the annual business meeting.

- Reminded everyone to send thank you letters.
- Reminder to purge our mailing listing to contain people who have attended the last three events.
- Recapped the Foundation Board Members and Executive Committee election from November 2020.
- Proposed dates for the 2022 (49th) event are April 29 May 1, 2022, so mark your calendars. Next year's event chair person is once again Kristin Korinko.
